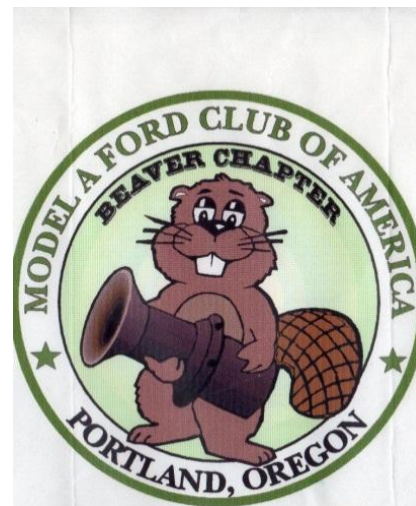

### Shifty Hood

This tip comes from the Colonial Virginia A's newsletter. Don Baxter added a nylon washer to the front of the center hood hinge rod to prevent the hood from shifting forward while employing speed reduction items.

## Protecting The Transmission When The Shifting Tower Is Removed - By Lynn Sondenaa

When the shifting tower has been removed from the transmission there is danger of dirt and foreign materials falling into the transmission case. To prevent the danger I made a cover for protection, it is made out of a piece of 12 gauge steel.

I used the shifting tower gasket for the bolt hole locations. Only the rear and center holes need to be drilled. I welded a 3 inch steel grab handle onto the center of the cover. This will allow the transmission to easily be carried. Also if you are removing or installing a Model A engine and transmission from a car or pickup you will now have an easy to use rear point handle. This greatly helps to get the engine and transmission placed into the correct position.

## FALL MEANS WARMER COATS

The green tweed coat on the left has slimming vertical seaming down the length of the coat, a side button closure and is trimmed with black velvet on its lapel collar, and cuffs.

The center coat may be an ensemble or the garment underneath it may be of similar fabric. This wrap coat ties at the side with a large bow. The fabric may be velvet, it has a nice flow to the skirt body of the coat.

The brown ensemble on the right is another side wrapped version. It is trimmed with fur on its stand up collar which continues down the front and finally wraps all around the hem line; the cuffs repeat the fur. As you can see the skirt under the coat is of the same fabric. That is why it is called an "ensemble" - the coat and the skirt or dress underneath it are of the same fabric. These are 1930 fashions.
